INSTRUCTIONSTOTHETENDERER

1. The bidder may download the Tender document from the website of <https://zpmansa.com> Please fill all the relevant blanks AND SIGN on all the pages of the annexures along with a stamp/ seal.
2. It should be clearly noted that this tender will be accepted manually only at Office of Zila Parishad, Mansa.
3. Tender Fee of Rs.5000/- (non-refundable) will be deposited through Demand Draft only.
4. Refundable Earnest Money Deposit (EMD) of Rs.5,00,000/- (Rupees Five Lacs Only) will be deposited through Demand Draft with tender documents.
5. The tenders without earnest money or short of it or not in the form specified above will not be entertained and shall be ignored straightway.
6. The committee reserves all rights to accept or reject the tender without assigning any reason and also to impose/relax any terms and conditions of the tender.

Terms and Conditions of the Tender

1. F.O.R.:

Destination at Civil Hospital Mansa (Punjab).

2. Eligibility:-

- a. The sole manufacturers/Authorized Dealer/ suppliers may quote their rates only.
- b. For items as per Annexure IV Bidder should have successfully supplied similar items to any medical college/Hospital/Govt. Department in the last years. Copy of Proof/Supply order will be attached with the tender documents.
- c. The bidder should have minimum average annual turnover of Rs. 10 Crores (Rupees Ten Crores only) during the last 3 financial years. Turnover certificate from Chartered Accountant should be submitted. Attested copies of audited profit and loss account and balance sheet statement for the three years should be attached (2017-18, 2018-19, 2019-20).

3. PRICE/TAXES:

Rates should be quoted for item basis without the condition of price escalation. Taxes/duties must be quoted separately. The award will be given to successful bidder on item basis.

4. PRICE/CERTIFICATE:

The tenderer must certify that the rate quoted by them are not higher than those quoted to other Government Departments in the State of Punjab.

5. Validity of Offer: Validity of offers should be 15 days from the date of award of tender.

6. PAYMENT : 70% Payment will be released after satisfactory Installation and first inspection and balance 30% will be made after 30 days of satisfactory second inspection of the material.

7. Guarantee/warranty:- All the material should carry full guarantee/warranty for a period of three years effective from the date of installation/supply.

8. Maintenance:- During the guarantee/warranty period, the supplier will be responsible for ensuring that the material is maintained in good working condition, all complaints will be attended by the firm promptly and in no case shall the delay in the same exceed 2 days. For delayed Service, a penalty of 2000/- per day will be charged.

9. Spares availability:- The successful bidder will guarantee that the material to be supplied is the latest model/technology and that spares for the material will be available for a period of at least 10 years and will also guarantee that they will keep the institution informed of any update of the material over a period of next 10 years. Training will be provided prior to installation/supply to ensure proper utilization and usage of the material and peripherals.

10. All the hospital equipment products should have CE Statement of compliance from a reputed certifying agency should be enclosed.
11. All the equipment's/products should be ISI certified and Branded. (Valid certificates should be attached with technical bid).
12. Demonstration of the quoted products should be required, which shall be done before pre-inspection price bid is opened.
13. The award of contract will be decided on the per item basis.
14. The successful bidder shall have to furnish a bank guarantee of @10% of the total value of the supply order from scheduled Banks of India as security for Guarantee/warranty period. The said Bank Guarantee could be forfeited in case of any breach of any condition on the part of the successful bidder.
15. Please note that tenderer should not quote the rates in the Technical Bid. Rates should only be quoted in the Financial Bid, failing which his offers will be rejected straightway.
16. The committee reserves the right to reject any or all tender(s) without assigning any reason.
17. **INSPECTION**: The inspection may be offered to this office within the stipulated delivery period and the inspection will be carried out by the technical committee jointly, before the dispatch, at the registered premises. You are, therefore, requested to keep items ready for inspection at your go down and dispatch only such material which has been duly inspected and accepted by this office.
18. **Penalty for delay in supply:-** The supply should be within 15 days from the date of issue of supply order by this office. For delayed supply, a penalty of 2% will be imposed on the total amount of supply order up to a delay of 7 days and thereafter 5% for another 7 days after which the supply order will be deemed cancelled and security/earnest money will be forfeited and company will be blacklisted for future.
19. Financial Bid will only be opened in case of those parties who meet all the technical specifications / requirements and terms and conditions of the NIT for Technical Offer. Prices should be quoted only in BOQ Sheet.
20. Rates quoted in the tenders shall be both in figures and words.
